We accept volunteer applications year round. A review board meets to review applications and conduct interviews.

Being a volunteer firefighter with the Husser Volunteer Fire Department requires a lot of responsibility and commitment. Volunteers are expected to attend drills and respond to calls when available.

The firefighter's family has to put up with a lot of inconveniences. Calls can occur any time of the day or night and the firefighter may come home dirty and physically exhausted. We stress safety through training and we use the best available equipment, but the potential for injury is always present.

The fire department provides training in firefighting, emergency medical services, safety, driving, and rescue skills.

Our firefighters both men and women, come from all walks of life. They are from different age groups and about the only common denominator they have is that all are stable, dedicated people with a desire to serve their community.
